Subject: **Admissions to BS Program for the Academic Year 2024-25**

1. According to the Admission Regulations of the University, the Rector has fixed the following schedule for admissions to BS Program for the academic session 2024-28. There will be **Two Rounds** of Admissions:-

**Late Admissions**

2. Admissions, after the expiry of the last date i.e. 06-09-2024, may be made in according with Rules and Regulations of Late Admissions under the following schedule:-

a.	With Late Fee of Rs.1000/-	09-09-2024 - 20-09-2024	27-09-2024
b.	With Late Fee of Rs.1500/-	23-09-2024 - 04-10-2024	11-10-2024
c.	*With Late Fee of Rs.2500/-	07-10-2024 - 11-10-2024	18-10-2024

\*(Subject to the sanction of the Rector at the time of admission. The last date for submission of Late Admission Forms is 11-10-2024.)

3. Provisional Admissions may be granted on Part-I Marks with Hope Certificate. However, admission will be cancelled if a candidate does not meet eligibility criteria (laid down in Point 7) after declaration of Intermediate/Equivalent result.

4. Equivalence Certificate (issued by IBCC i.e. Inter Boards Coordination Commission) of O & A Levels/Intermediate Certificate awarded by the foreign institutions is mandatory.
5. Registration Returns must be submitted on Prescribed Pro forma as per above schedule. Registration Returns Pro forma will be shared in due course of time.

#### **Fee Structure for Academic Year 2024-25**

6. The University has fixed the following Fee for Academic Session 2024-25.
  - a. Registration Fee: PKR 10,000/- per student (one-time payment)
  - b. Examination Fee: PKR 8,000/- per student/per semester

#### **Eligibility Criteria**

7. The University lays down the following criteria for admissions in BS Program:-
  - a. BBA(Hons), BS Economics, BS English, BS Fine Arts, BS Health & Physical Education, BS Islamic Studies, BS Political Science, BS Special Education, BS Psychology, BS Urdu:  
At least 50% marks in Intermediate/12 years schooling/A-Level (HSSC) or Equivalent.
  - b. BS Botany: At least 50% marks in Intermediate/12 years schooling/A-Level (HSSC) or Equivalent with Biology.
  - c. BS Computer Science, BS IT, BS Mathematics: At least 50% marks in Intermediate/12 years schooling/A-Level (HSSC) or Equivalent with Mathematics. The students who have not studied Mathematics at intermediate level are eligible to apply for BS Computer Science and BS IT, but they will have to pass two Deficiency Courses of Mathematics (06 credits) in the First Two semesters.
  - d. BS Physics: At least 50% marks in Intermediate/12 years schooling/A-Level (HSSC) or Equivalent with Physics.
  - e. Diploma holders DAE/ D.Com are not eligible to apply for admission to BS Program.

#### **Open Merit Calculation**

8. Merit for Admissions to BS Program will be calculated by the following formula:-
  - a. Matric or Equivalent = 20%
  - b. HSSC or Equivalent = 80%
